

GOVERNMENT OF THE REPUBLIC OF LITHUANIA

RESOLUTION No 207 DECLARING QUARANTINE ON THE TERRITORY OF THE REPUBLIC OF LITHUANIA

14 March 2020
Vilnius

In pursuance of Articles 25 and 27 of Regulation (EU) 2016/399 of the European Parliament and of the Council of 9 March 2016 on a Union Code on the rules governing the movement of persons across borders (Schengen Borders Code), Article 21(3)(1) of the Law of the Republic of Lithuania on the Prevention and Control of Communicable Diseases in Humans, Article 21 (2)(1) of the Law on Civil Protection, having regard to the adverse epidemic COVID-19 (coronavirus infection) situation and the submission by the Minister for Health, also to the recommendation by the Emergency Commission of the Government of the Republic of Lithuania of 14 March 2020, the Government of the Republic of Lithuania has resolved:

1. To declare the tertiary (absolute preparedness) level of preparedness of the civil protection system.
2. To declare quarantine on the entire territory of the Republic of Lithuania.
3. To impose the quarantine regime as detailed below:

3.1. Regarding cross-border and domestic movements:

3.1.1. To prevent the entry of foreigners into the Republic of Lithuania, except for the citizens of the Republic of Poland and persons lawfully residing in the Republic of Poland, provided that they have not travelled outside the Republic of Poland in the past 14 days before the entry to the Republic of Lithuania, arriving for the purpose of work, business or studies, the citizens of the Republic of Estonia or of the Republic of Latvia and persons lawfully residing in these countries, provided that they have not travelled outside the Republic of Latvia and the Republic of Estonia in the past 14 days before the entry to the Republic of Lithuania, foreigners who are family members of the citizens of the Republic of Lithuania (parents (adoptive parents), children (adopted children), spouses and carers), also the crew members, who are employed in Lithuanian companies engaged in international commercial transportation, or who carry out international commercial transportation by all the means of transport, persons entitled to reside in the Republic of Lithuania, persons enjoying immunities and privileges under the Vienna Convention on Diplomatic Relations (1961) and the Vienna Convention on Consular Relations (1963) and persons serving in the military units of NATO and of NATO countries and the personnel serving them and their family members, health professionals arriving for the provision of transplant services, journalists entering the Republic of Lithuania at the permission of the Minister for Foreign Affairs, also the exceptions referred to in paragraph 3.1.3 of this Resolution, and the foreigners who, in exceptional cases, shall be allowed entry to the Republic of Lithuania on the basis of an individual permission by a minister holding the jurisdiction in the respective realm, and whose entry has been approved by the Government. The crew members, who

carry out international commercial transportation by all the means of transport, shall transit through the territory of the Republic of Lithuania without a necessary stop.

3.1.2. State border crossing shall be carried out at the following international border crossing points:

3.1.2.1. by road: Kalvarija - Budzisko, Saločiai - Grenstale, Butingė - Rucava, Smėlynė - Medume, Medininkai - Kamenyi Log, Raigardas - Privalka, Kybartai - Chernyshevskoye, Panemunė - Sovetsk, Šalčininkai - Benjekoni, Lazdijai - Ogrodniki. The entry of persons and/or their private passenger cars into the territory of the Republic of Lithuania shall be allowed only at the following international state border crossing points: Kalvarija - Budzisko, Saločiai - Grenstale and Lazdijai - Ogrodniki. The entry of diplomatic transport shall be allowed at all the road state border crossing points. In exceptional cases, the entry of persons and/or their private passenger cars shall be allowed into the territory of the Republic of Lithuania at other international border crossing points specified in this subparagraph, where there is a permission by the Head of the State Border Guard Service under the Ministry of the Interior of the Republic of Lithuania or his authorised person.

[(*effective as of 18-05-2020*). 3.1.2.1. by road: Kalvarija - Budzisko, Saločiai - Grenstale, Butingė - Rucava, Smėlynė - Medume, Kalviai - Meitene, Medininkai - Kamenyi Log, Raigardas - Privalka, Kybartai - Chernyshevskoye, Panemunė - Sovetsk, Šalčininkai - Benjekoni, Lazdijai - Ogrodniki. The entry of persons and/or their private passenger cars into the territory of the Republic of Lithuania shall be allowed only at the following international state border crossing points: Kalvarija - Budzisko, Saločiai - Grenstale, Butingė - Rucava, Smėlynė - Medume and Lazdijai - Ogrodniki. The entry of diplomatic transport shall be allowed at all the road state border crossing points. In exceptional cases, the entry of persons and/or their private passenger cars shall be allowed into the territory of the Republic of Lithuania at other international border crossing points specified in this subparagraph, where there is a permission by the Head of the State Border Guard Service under the Ministry of the Interior of the Republic of Lithuania or his authorised person.]

3.1.2.2. by railway: Vilnius railway station, Stasylos - Benjekoni, Kena- Gudagai, Šeštokai – Trakiszki. Border crossing for commercial and/or international freight transportation shall be additionally carried out at the following international state border railway crossing points: Stasylos – Benjekoni, Pagėgiai - Sovetsk, Joniškis - Meitene, Turmantas – Kurcums and Kybartai - Nesterov;

3.1.2.3. airports: Vilnius, Kaunas, Palanga and Šiauliai international airports' border checkpoints;

3.1.2.4. sea ports: Pilies, Malkų įlankos, Būtingė oil terminal and Molo border crossing points.

3.1.3. A transit of persons returning to their country of residence or in whose respect a reasoned request has been made by a foreign country, also seafarers shall be allowed through the territory of the Republic of Lithuania without a necessary stop, in formed groups of persons or vehicles with ensured compulsory escort (convoy) of these groups from the entry into the Republic of Lithuania to the departure from it through the international border crossing points. The requirement to form a group of persons or vehicles and to ensure the compulsory escort (convoy) of these groups from the entry into the Republic of Lithuania to the departure from it through the international border crossing points shall not apply in the case of the citizens of the Republic of Estonia and of the Republic of Latvia and of persons lawfully residing in these countries. The facilitated transit of

persons through the Republic of Lithuania from the territory of the Russian Federation to Kaliningrad region of the Russian Federation and backwards shall be carried out only at Kena railway border checkpoint and Kybartai railway border checkpoint under the conditions laid down by the Minister for Foreign affairs of the Republic of Lithuania. The transit of seafarers may be carried out after the shipping company or the ship's agent has ensured their safe transportation from the entry into the Republic of Lithuania to the departure from it through the international border crossing points.]

3.1.4. *Repealed as of 04-05-2020.*

3.1.5. Persons who have returned or arrived from foreign countries shall fall subject to 14 days' isolation, except for the citizens of the Republic of Poland and persons lawfully residing in the Republic of Poland, returning or arriving for the purpose of work, business or studies, and the citizens of the Republic of Lithuania returning or arriving from the Republic of Poland, where they went for the purpose of work, business or studies and travelled only within the territory of the Republic of Poland, the citizens of the Republic of Estonia and of the Republic of Latvia and the citizens of the Republic of Lithuania and persons lawfully residing in these countries returning or arriving from the Republic of Estonia and from the Republic of Latvia, where they travelled only within the territory of the Republic of Estonia, the Republic of Latvia or the Republic of Lithuania, the crew members, who are employed in Lithuanian companies engaged in international commercial transportation, or who carry out international commercial transportation by all the means of transport, health professionals arriving for the provision of transplant services, journalists entering the Republic of Lithuania at the permission of the Minister for Foreign Affairs and members of official delegations, diplomats and special couriers working on transit trains referred to in paragraph 3.1.3 of this Resolution, and citizens of foreign countries transiting through the Republic of Lithuania, who have no COVID-19 (coronavirus infection) symptoms. The crew members, who are employed in Lithuanian companies engaged in international commercial transportation, or who carry out international commercial transportation by all the means of transport, shall fall subject to isolation from the day of arrival in the Republic of Lithuania until the day of departure from its territory, but no longer than 14 days. The National Public Health Centre under the Ministry of Health shall organise screening of all persons who have returned or arrived from abroad, except for the returning or arriving citizens of the Republic of Estonia, the Republic of Latvia and of the Republic of Lithuania and persons lawfully residing in these countries, where they travelled only within the territory of the Republic of Estonia, the Republic of Latvia or of the Republic of Lithuania, for the symptoms of COVID-19 (coronavirus infection) at the international border crossing points referred to in paragraph 3.1.2 of this Resolution. Where the crew members transiting through the territory of the Republic of Lithuania while carrying out international commercial transportation by all the means of transport, are found to have the symptoms of COVID-19 (coronavirus infection), the State Border Guard Service under the Ministry of the Interior of the Republic of Lithuania shall prevent the entry of these persons into the territory of the Republic of Lithuania, except for the citizens of the Republic of Lithuania and persons entitled to reside in the Republic of Lithuania.

3.1.6. Restrictions shall be imposed on the flows of passengers using long-distance and suburban regular passenger transport services: they shall be required to travel seated maintaining the distance of at least one meter from each other. Special safety precautions shall be taken by disinfecting

the vehicles at the beginning and end of the trip for each route. This provision is recommended for urban passenger transport too.

3.1.7. Entry of cruise ships into Klaipėda State Seaport shall be prohibited.

3.1.8. Protective equipment (personal protection and medical device class I: protective spectacles and visors, face shields, mouth-nose-protection equipment and protective garments) listed in Annex I to Commission Implementing Regulation (EU) 2020/568 of 23 April 2020 making the exportation of certain products subject to the production of an export authorisation, shall be allowed to be exported to third countries, with the exceptions referred to in Article 2(4) and (5) of Implementing Regulation (EU) 2020/568, only at the decision of the State Commander of National Emergency Operations. The movement of other goods shall not be restricted.

3.1.9. *Repealed as of 10-04-2020.*

3.1.10. To obligate people:

3.1.10.1. to visit or stay in parks and other open public places in groups of no more than five, except for close relatives, adoptive parents, adoptive children, guardians and carers, while keeping a safe distance (more than 2 meters and less than 15 minutes contact), avoiding direct physical contact and observing personal hygiene requirements;

3.1.10.2. who are above six years of age, to wear protective equipment covering nose and mouth (face masks, respirators or other equipment):

3.1.10.2.1. outdoor spaces: marketplaces and other public points of sale, events, excursions, public transport boarding points;

3.1.10.2.2. in public indoor spaces, except:

3.1.10.2.2.1. when eating and drinking in catering establishments referred to in paragraph 3.2.6. of this Resolution;

3.1.10.2.2.2. when exercising.

3.1.10¹ To recommend that persons above six years of age wear protective equipment covering nose and mouth (face masks, respirators or other equipment) in public outdoor spaces other than those referred to in paragraph 3.1.10.2 of this Resolution.

3.1.11. Transportation of passengers and/or their private passenger cars to the Republic of Lithuania by passenger ships/ferries shall be prohibited, except for the ferries running on the routes between Kiel - Rostock - Travemünde and Klaipėda, where passengers are not picked up at intermediate ports and where the minimum contact with bystanders is ensured at the intermediate ports during the change of ferries. At the submission of the Minister of Foreign Affairs, in exceptional cases, a decision regarding permission shall be taken by the Government of the Republic of Lithuania.

3.1.12. Regular passenger flights to international airports of the Republic of Lithuania shall only be allowed on the routes that have been approved to resume by the Government at the recommendation of the Minister for Foreign Affairs. Non-scheduled flights carrying more than 10 passengers to international airports of the Republic of Lithuania shall fall subject to an individual permission to operate issued by the Lithuanian Transport Safety Administration.

3.2. Regarding the activities of public and private sectors:

3.2.1. State and municipal institutions and bodies and state and municipal enterprises shall organise their work and provide customer services remotely, except where the functions (tasks) concerned must be performed at the workplace. The performance of urgent and immediate functions (tasks) shall be ensured. The private sector is recommended to organise its work in the same manner as the public sector.

[(*effective as of 18-05-2020*)]. 3.2.1. State and municipal institutions and bodies and state and municipal enterprises shall organise their work and provide customer services in such a way as to ensure the required conditions laid down by the State Commander of National Emergency Operations for public health safety, hygiene and the provision of persons with necessary personal protective equipment, or remotely. The private sector is recommended to organise work in the same manner as the public sector.]

3.2.1¹. Downtime shall not be enforced on the employees of state and municipal budget establishments, health establishments, regardless of their subordination and legal form, unless all the possible forms and methods of work arrangement, including remote training, have been exhausted, where following the declaration of a state of emergency and quarantine by the Government of the Republic of Lithuania, the employer cannot provide the employee with work agreed in the employment contract and there is no possibility to do the work under the contract remotely or the employee does not agree to do another job offered.

3.2.1². It shall be allowed to organise:

3.2.1².1. with regard to all the means of transport:

3.2.1².1.1. examinations for the assessment of driving skills and abilities;

3.2.1².1.2. theoretical training in driving skills and abilities remotely or by ensuring the required conditions laid down by the State Commander of National Emergency Operations for public health safety, hygiene and the provision of persons with necessary personal protective equipment;

3.2.1².1.3. practical training in driving skills and abilities provided the required conditions laid down by the State Commander of National Emergency Operations for public health safety, hygiene and the provision of persons with necessary personal protective equipment are ensured;

3.2.1².2. foreign language proficiency assessment examinations (credits) for persons applying to foreign higher education establishments, provided that there are no more than 10 participants in the examination (credit), while also ensuring at least 10 sq. m. of space per person and the distance of at least 2 m between the persons.

3.2.2. Cultural, leisure, entertainment and sports establishments shall not be visited, and no services shall be provided to visitors. This prohibition shall not apply to high-performance athletic training of the athletes who have met the requirements for the Olympic and Paralympic Games, candidates of the Olympic team, athletes preparing for the deaf championships, also for the world or European championships, and athletes of national teams or other team sports preparing for tournaments (leagues). Nor shall this prohibition apply to groups of no more than two people, except for close relatives, adoptive parents, adoptive children, guardians, and carers:

3.2.2.1. for outdoor leisure activities, provided that at least 10 sq. m. of space per visitor and the distance of at least 10 m between people and/or groups of people is ensured;

3.2.2.2. for visits to learning and educational trails (except observation towers), parks, zoos and botanical gardens located in open outside areas, provided that the distance of at least 2 m between people and/or groups of people is ensured;

3.2.2.3. for high-performance athletic training in engineered open-air sports facilities, provided that at least 10 sq. m. of space per visitor and the distance of at least 10 m between people and/or groups of people is ensured;

3.2.2.4. for visits to archives, libraries and museums, provided that at least 10 sq. m. of space per visitor and the distance of at least 2 m between people and/or groups of people is ensured.

[(*effective as of 18-05-2020*). 3.2.2. Cultural, leisure, entertainment and sports establishments shall not be visited, and no services shall be provided to visitors. This prohibition shall not apply to:

3.2.2.1. high-performance athletic training;

3.2.2.2. individual sports activities, physical activity exercises (conducted by a physical activity or high-performance sports instructor or physical activity professional with no more than 10 participants, except for close relatives, adoptive parents, adoptive children, guardians, and carers), provided that in all the cases at least 5 sq. m. of space per person and the distance of at least 2 m between people and/or groups of people is ensured;

3.2.2.3. groups of no more than 5 persons, except for close relatives, adoptive parents, adoptive children, guardians, and carers:

3.2.2.3.1. for outdoor leisure activities, provided that at least 5 sq. m. of space per person and the distance of at least 2 m between people and/or groups of people is ensured;

3.2.2.3.2. for visits and excursions to learning and educational trails, observation towers, parks, zoos and botanical gardens located in open areas, provided that the distance of at least 2 m between people and/or groups of people is ensured;

3.2.2.3.3. for visits and excursions to archives, libraries and museums, provided that at least 5 sq. m. of space per visitor and the distance of at least 2 m between people and/or groups of people is ensured.]

3.2.3. All indoor and outdoor events and gatherings shall be prohibited. This prohibition shall not apply to the outdoor events, where people stay in their cars during the event, and where there are no more than two people in the car, except for close relatives, adoptive parents, adoptive children, guardians, and carers.

[(*effective as of 18-05-2020*). 3.2.3. All indoor and outdoor events and gatherings shall be prohibited. This prohibition shall not apply to the outdoor events:

3.2.3.1. where people stay in their cars during the event, and where there are no more than two people in the car, except for close relatives, adoptive parents, adoptive children, guardians, and carers;

3.2.3.2. where there are no more than 30 participants in the event and at least 10 sq. m. of space per participant and the distance of at least 2 m between people is ensured.]

[(*effective as of 30-05-2020*). 3.2.3. All indoor and outdoor events and gatherings shall be prohibited. This prohibition shall not apply to the events:

3.2.3.1. outdoors, where people stay in their cars during the event, and where there are no more than 2 people in the car, except for close relatives, adoptive parents, adoptive children, guardians, and carers;

3.2.3.2. outdoors and indoors, where there are no more than 30 participants (spectators) in the event and at least 5 sq. m. of space per person and the distance of at least 2 m between people is ensured;

3.2.3.3. outdoor and indoor high-performance athletic competitions without the participation of spectators;

3.2.3.4. private celebrations in public outdoor and indoor spaces with no more than 30 persons participating in the celebration.]

3.2.4. The activities of wellness and health centres offering recreational services shall be prohibited. Spas shall be free to provide only medical rehabilitation services.

[3.2.4. *Repealed as of 30-05-2020.*]

3.2.5. The provision of accommodation services, rent of premises and apartments and other provision thereof for short-term accommodation of natural persons may be prohibited in each municipality by a separate decision of the director of the municipal administration. Hotels and other premises shall be used for the isolation of people through an individual agreement between a municipality and an accommodation service provider or at the request of the director of a municipal administration.

3.2.6. The activities of catering facilities, restaurants, cafes, bars, nightclubs and other entertainment venues shall be prohibited. The prohibition shall not apply in the following cases:

3.2.6.1. where food can be taken away or it can be otherwise delivered to natural and legal persons;

3.2.6.2. where catering is organised in open spaces.

[(*effective as of 18-05-2020*). 3.2.6. The activities of catering facilities, restaurants, cafes, bars, nightclubs and other entertainment venues shall be allowed from 8:00 to 22:00 hrs. The working time restrictions shall not apply in the cases:

3.2.6.1. of takeaway food or where food is otherwise delivered to natural and legal persons;

3.2.6.2. where catering is organised in outdoor spaces.]

3.2.7. Stores, marketplaces and other public points of sale shall be permitted to resume their activities, provided that at least 10 sq. m. of space per buyer is ensured or no more than one buyer is served at a time.

3.2.8. Beauty services shall be closed. This requirement shall not apply in the case of hair care and nail care services, if the flow of service users and other visitors is restricted at the points of service by ensuring at least 10 sq. m. of service space per service user or other visitor, or by serving no more than one service user at a time.

[3.2.8. *Repealed as of 18-05-2020.*]

3.2.8.¹ It shall be allowed to provide services at points of service, except where it is provided otherwise in other paragraphs of this Resolution, if the flow of service users and other visitors is restricted at the points of service by ensuring at least 10 sq. m. of retail space per service user or other visitor, or by serving no more than one service user at a time.

3.2.8.² The required conditions laid down by the State Commander of National Emergency Operations for public health safety, hygiene and the provision of persons with necessary personal protective equipment shall be ensured at points of sale and service or points of economic activity referred to in paragraphs 3.2.1², 3.2.2, 3.2.3, 3.2.6, 3.2.7, 3.2.8 and 3.2.8¹ and 3.2.13 of this Resolution, whose activities have not been prohibited.

[(*effective as of 18-05-2020*)]. 3.2.8.² The required conditions laid down by the State Commander of National Emergency Operations for public health safety, hygiene and the provision of persons with necessary personal protective equipment shall be ensured at points of sale and service or points of economic activity referred to in paragraphs 3.2.1², 3.2.2, 3.2.3, 3.2.6, 3.2.7, 3.2.8¹, 3.2.9, 3.2.13 and 3.3 of this Resolution, whose activities have not been prohibited.]

3.2.9. Casinos and amusement arcades shall be closed.

[(*effective as of 18-05-2020*)]. 3.2.9. The activities of gambling houses (casinos) and amusement arcades shall be allowed from 8:00 to 22:00 hrs.]

3.2.10. Visiting sentenced and arrested persons shall be prohibited, except their meetings with lawyers.

3.2.11. Non-cash settlements are recommended.

3.2.12. During the quarantine period and 14 calendar days after the quarantine period, petrol containing less than 10% of biofuels may be sold at fuel points of sale, subject to quality standard requirements. Bioethanol that has not been used for the production of biofuels shall be used for medical or disinfection purposes.

3.2.13. Sailing shall be prohibited on small, recreational, sports, private and conventional vessels and other floating equipment or means. When sailing in groups of more than two people, the distance of at least 1 m shall be maintained between the people (except for close relatives, adoptive parents, adoptive children, guardians, and carers) and the required conditions laid down by the State Commander of National Emergency Operations for public health safety, hygiene and the provision of persons with necessary personal protective equipment shall be ensured.

[(*effective as of 18-05-2020*)]. 3.2.13. Sailing shall be restricted on small, recreational, sports, private and conventional vessels and other floating equipment or means. When sailing in groups of more than 5 people, the distance of at least 1 m shall be maintained between the people (except for close relatives, adoptive parents, adoptive children, guardians, and carers) and the required conditions laid down by the State Commander of National Emergency Operations for public health safety, hygiene and the provision of persons with necessary personal protective equipment shall be ensured.]

3.3. Regarding the organisation of work in educational establishments.

The educational and childcare process as well as the educational activities in all educational establishments and day care centres shall be suspended, organising instead the remote educational process.

[(*effective as of 18-05-2020*)]. **3.3. Regarding the organisation of work in educational establishments.**

The educational and childcare process as well as the educational activities in all educational establishments and day care centres shall be suspended, organising instead the remote educational process, except for pre-school, pre-primary and non-formal education. Pre-school, pre-primary and

non-formal education of children shall be carried out by ensuring the required conditions laid down by the State Commander of National Emergency Operations for public health safety, hygiene and the provision of persons with necessary personal protective equipment.]

[(*effective as of 25-05-2020*)]. **3.3. Regarding the organisation of work in educational establishments.**

3.3.1. The educational establishments shall be allowed:

3.3.1.1. to carry out pre-school, pre-primary and non-formal education;

3.3.1.2. to carry out primary education and provide educational assistance to pupils following pre-school, pre-primary and primary education programmes in school, if such a decision of the school principle is agreed with the school council and the institution implementing the owner's rights and responsibilities (state schools - budgetary institutions), municipal executive body or its authorised person (municipal schools - budgetary institutions), meeting of stakeholders (owner) (state, municipal schools - public institutions and non-state schools), as well as to hold consultations in school for graduates of a secondary school preparing for maturity examinations and to provide them with educational assistance;

3.3.1.3. to carry out education of pupils in special schools for pupils with special education needs due to congenital or acquired disorders, and in special (educational) classes of general education schools following the programmes of primary education (individualised primary education), basic education (individualised basic education) and secondary education (social skills education) and to provide educational assistance, if such a decision of the school principle is agreed with the school council and the institution implementing the owner's rights and responsibilities (state schools - budgetary institutions), municipal executive body or its authorised person (municipal schools - budgetary institutions), meeting of stakeholders (owner) (state, municipal schools - public institutions and non-state schools);

3.3.1.4. to conduct in general education schools consultations (individual and group) and to provide educational assistance to pupils who did not have adequate conditions for remote learning under the primary education programme (absence of equipment, internet, no appropriate adult assistance, etc.), if a general education school principle decides not to resume educational process under the primary education programme in school;

3.3.1.5. to carry out higher education studies that cannot be carried out remotely and vocational training that cannot be carried out remotely or when it is carried out on an individual basis.

3.3.2. Basic and secondary education shall be carried out remotely.

3.3.3. The head of an educational establishment or other education provider may decide to carry out educational process remotely.]

[(*effective as of 30-05-2020*)]. **3.3. Regarding the organisation of work in educational establishments.**

3.3.1. The educational establishments shall be allowed:

3.3.1.1. to carry out pre-school, pre-primary and non-formal education;

3.3.1.2. to carry out primary education and provide educational assistance to pupils following pre-school, pre-primary and primary education programmes in school, if such a decision of the school principle is agreed with the school council and the institution implementing the owner's rights and

responsibilities (state schools - budgetary institutions), municipal executive body or its authorised person (municipal schools - budgetary institutions), meeting of stakeholders (owner) (state, municipal schools - public institutions and non-state schools), as well as to hold consultations in school for graduates of a secondary school preparing for maturity examinations and to provide them with educational assistance;

3.3.1.3. to carry out education of pupils in special schools for pupils with special education needs due to congenital or acquired disorders, and in special (educational) classes of general education schools following the programmes of primary education (individualised primary education), basic education (individualised basic education) and secondary education (social skills education) and to provide educational assistance, if such a decision of the school principle is agreed with the school council and the institution implementing the owner's rights and responsibilities (state schools - budgetary institutions), municipal executive body or its authorised person (municipal schools - budgetary institutions), meeting of stakeholders (owner) (state, municipal schools - public institutions and non-state schools);

3.3.1.4. to conduct in general education schools consultations (individual and group) and to provide educational assistance to pupils who did not have adequate conditions for remote learning under the primary education programme (absence of equipment, internet, no appropriate adult assistance, etc.), if a general education school principle decides not to resume educational process under the primary education programme in school;

3.3.1.5. to carry out higher education studies that cannot be carried out remotely and vocational training that cannot be carried out remotely or when it is carried out on an individual basis;

3.3.1.6. to carry out basic and secondary education in schools and to provide educational assistance to pupils following the primary and secondary education programmes, if such a decision of the school principle is agreed with the school council and the institution implementing the owner's rights and responsibilities (state schools - budgetary institutions), municipal executive body or its authorised person (municipal schools - budgetary institutions), meeting of stakeholders (owner) (state, municipal schools - public institutions and non-state schools);

3.3.1.7. to conduct in general education schools consultations (individual and group) and to provide educational assistance to pupils who did not have adequate conditions for remote learning under the primary education programme (absence of equipment, internet, no appropriate adult assistance, etc.), if a general education school principle decides not to resume educational process under the basic and secondary education programme in school;

3.3.1.8. to carry out non-formal adult education, where the specificity of the programme prevents it from being carried out remotely;

3.3.2. The head of an educational establishment or other education provider may decide to carry out educational process remotely.]

3.4. Regarding the organisation of work in health institutions:

3.4.1. Mobilising health professionals, university and non-university students and residency students and using infrastructure, regardless of their subordination. If necessary, health professionals and staff working with them (personnel serving the medical staff) may be temporarily transferred to

another health establishment or their job functions may be temporarily changed in order to ensure the proper organisation of health services.

3.4.2. Operational reorganisation in managing patient flows, infrastructure and material and human resources.

3.4.3. Provision of inpatient health services, regardless of the subordination and legal form of the health establishment providing these services:

3.4.3.1. Provision of inpatient health services, where failure to provide them would result in patient's need for medical emergency or a significant deterioration of his condition.

3.4.3.2. Visiting patients shall be prohibited, except patients in terminal condition and children under 14 years of age, with the permission of the treating physician.

[(*effective as of 18-05-2020*). 3.4.3.2. Visiting patients shall be allowed with the permission of the treating physician and following the procedure laid down by the head of the healthcare establishment.]

3.4.4. Provision of outpatient health services, regardless of the subordination and legal form of the healthcare establishment providing these services:

3.4.4.1. Provision of remote services: prescription of medicines and medical aids, consultations, issuance and extension of electronic certificates of incapacity for work, consultations between physicians, referral for required medical tests, nurse consultation.

3.4.4.2. Provision of outpatient health services, where failure to provide them would result in patient's need for medical emergency or a significant deterioration of his condition.

3.4.4.3. Restrictions on home care services other than outpatient nursing and palliative care services, except where failure to provide them would result in patient's need for medical emergency or a significant deterioration of his condition.

3.4.4.4. Reorganisation of preventive examinations and prevention programmes and military forensics performed by the units of the Lithuanian Armed Forces in charge of medical support, as well as of the specialised forensics performed by the Medical Centre under the Ministry of the Interior of the Republic of Lithuania, while providing for the management of patient flows.

3.4.4.5. Reorganisation of routine vaccinations, while providing for the management of patient flows.

3.4.5. Routine inpatient health services (including day surgery and services provided in a day hospital), routine inpatient medical rehabilitation services, routine outpatient consultations, diagnostic, preventive and treatment health services and outpatient medical rehabilitation services shall be postponed and shall not resume unless the establishment, regardless of its subordination and legal form, prepares a plan for a phased resumption and provision of inpatient health services in the establishment and/or a plan for a phased resumption and provision of outpatient health services in the establishment, agrees it with the infection control specialist (if such a specialist has been appointed), and if it is an inpatient healthcare establishment specified in paragraph 8 of the Procedure for the Organisation of Coronavirus (COVID-19) Related Health Services, approved by Order No V-281 of the Minister for Health of the Republic of Lithuania of 4 March 2020 approving the Procedure for the Organisation of Coronavirus (COVID-19) Related Health Services - it agrees the plan with the healthcare establishment organising the provision of COVID-19-related services in the relevant area

of operation, approves the plan and submits it to the National Public Health Centre under the Ministry of Health. The plan shall include the institutional reserve infrastructure required for emergency medical services and routine services, along with the procedures for the management of high-risk and low-risk patient flows, the procedure for the provision of health services (service group), and the procedure for the organisation of staff work and measures to manage the possible spread of COVID-19 (coronavirus infection) in other establishments (when an employee works in other establishments too), as well as the procedure for assigning personal protective equipment to the staff and patients of the establishment according to safety levels.

[(*effective as of 18-05-2020*). 3.4.5. Routine inpatient health services (including day surgery and services provided in a day hospital), routine inpatient medical rehabilitation services, routine outpatient consultations, diagnostic, preventive and treatment health services, outpatient medical rehabilitation services and inpatient and outpatient dental services shall be postponed and shall not resume unless the establishment, regardless of its subordination and legal form, prepares a plan for a phased resumption and provision of inpatient health services in the establishment and/or a plan for a phased resumption and provision of outpatient health services in the establishment, agrees it with the infection control specialist (if such a specialist has been appointed), and if it is an inpatient healthcare establishment specified in paragraph 8 of the Procedure for the Organisation of Coronavirus (COVID-19) Related Health Services, approved by Order No V-281 of the Minister for Health of the Republic of Lithuania of 4 March 2020 approving the Procedure for the Organisation of Coronavirus (COVID-19) Related Health Services - it agrees the plan with the healthcare establishment organising the provision of COVID-19-related services in the relevant area of operation, approves the plan and submits it to the National Public Health Centre under the Ministry of Health. The plan shall include the institutional reserve infrastructure required for emergency medical services and routine services, along with the procedures for the management of high-risk and low-risk patient flows, the procedure for the provision of health services (service group), and the procedure for the organisation of staff work and measures to manage the possible spread of COVID-19 (coronavirus infection) in other establishments (when an employee works in other establishments too), as well as the procedure for assigning personal protective equipment to the staff and patients of the establishment according to safety levels.]

3.4.6. Medical establishments that are part of the Lithuanian Public Health System (hereinafter 'the Public Health System') shall process all the patient data related to the delivery of health services, including case summaries, referrals, outcomes of referrals,, medical images and their descriptions, only through the Electronic Health Services and Cooperation Infrastructure Information System, and medical establishments that are not part of the Public Health System shall ensure the processing of these data and their traceability through its own information system.

3.4.7. The requirements for the plan for a phased resumption and provision of inpatient health services in the establishment and/or a plan for a phased resumption and provision of outpatient health services in the establishment shall be laid down by decisions of the State Commander of National Emergency Operations.

3.4.8. Postponement of dental services other than emergency medical care.

[3.4.8. *Repealed as of 18-05-2020*].

3.4.9. Reorganisation of pharmacy activities to avoid direct human contact.

3.4.10. Public health:

3.4.10.1. Postponement of measures to strengthen public health and prevent chronic non-communicable diseases.

3.4.10.2. Postponement of public health control routine inspections.

3.4.10.3. Postponement of other non-urgent public health measures.

3.4.10. *Repealed as of 30-05-2020*].

3.5. Regarding the organisation of work in social service establishments:

3.5.1. Attending all inpatient social service establishments, foster families, group and community homes shall be prohibited.

3.5.2. Contacting clients of other social service establishments shall be allowed only for the purpose of ensuring the delivery of the essential social services.

[3.5.2. *Repealed as of 18-05-2020*].

3.5.3. Activities in day care centres for children, persons with disabilities and the elderly shall be prohibited. Municipal administrations must ensure the care of, the arrangement of meals and distance learning for children and persons with disabilities in establishments, where there is request from parents, adoptive parents, guardians or carers and a certificate from the employer on the need to perform relevant functions (work) at the workplace, or where it is not possible to provide care for children or people with disabilities at home.

4. To instruct:

4.1. the State Commander of National Emergency Operations to lay down concrete measures for the quarantine regime, following the recommendations of the responsible ministry regarding the immediate measures for the quarantine regime;

4.2. the state and municipal institutions and bodies, as well as the institutions and enterprises of the Lithuanian national health system to submit to the Ministry of Health or its authorised body, every day by 7:00, the statistics in accordance with the list of statistics approved by the decision of the State Commander of National Emergency Operations, covering the last 24 hours and recorded by 3:00.

4.3. the state and municipal institutions and bodies and the establishments and enterprises of the Lithuanian national health system to ensure the adoption and/or withdrawal of measures assigned to them by the decision of the State Commander of National Emergency Operations, 24 hours a day.

5. To recommend that all the religious communities operating in Lithuania refrain from holding religious ceremonies with a view to preventing public gatherings.

6. The quarantine regime shall be effective from 16 March 2020, 00:00, until 31 May 2020, 24:00.
